Dear Candidate,

Please find enclosed the Test Report Form (TRF) giving the results of the IELTS Test, which you recently took at our centre. We hope they are what you were hoping for.

The rules governing the issuing of TRFs are strict.

1. Your TRF is a valuable document. **TRF replacement is not provided in case of loss.**
2. We are permitted to issue only one TRF directly to you, all duplicates are sent to receiving organizations **only.**
3. We can issue up to five duplicate TRFs at no extra charge if the IELTS receiving organizations have been detailed in your Application Form. All TRFs are mailed to receiving organizations in your Application Form via registered post (KazPost) that takes 2 to 4 weeks depending on destination point. You are free to choose other courier service, but in this case you will need to cover the delivery expenses.
4. If you need more than five duplicates of your TRF to be sent to the receiving organizations or you have not listed the IELTS receiving organizations in your Application Form you can ask to send duplicate/s within three months of your test date each extra duplicate will cost 100 KZT, after the 3 month period (for a period of two years) we will make an administrative charge of 2100 KZT. For this purpose you will need to fill in "Application for the Issue of Additional TRF" document available at the Centre and on www.ielts.kz web site and cover courier fee. You are free to choose any courier service which suits you best.
5. Please note that we are unable to send / issue your results to immigration agencies that prepare documents for your immigration process.

Please also remember this further point about your TRF and about the IELTS test results: your IELTS result is normally considered valid for two years. If you need to demonstrate your level of English after this, you may need to take the test again.

If you are unhappy with your Test results, you can start the Enquiry on Results (EoR) procedure by which you can request to have your papers re-marked. You must apply for a re-mark at KZ005 IELTS Test Centre within six weeks of the Test date, after the test results have been released.

The rules governing the EoR procedure:

1. You must complete an EoR form, available from KZ005 IELTS Test Centre. You can apply for a full re-mark (i.e. all test papers) or a partial re-mark (i.e. one or more test).
2. The re-mark fee applicable for both partial and full re-mark - AUD\$ 160.00 in local currency according to the official exchange rate on the date of submitting the EoR form.
3. You must return the original TRF applying for the EoR.
4. You will be notified (by a pro forma letter) of the re-mark result no later than eight weeks after submitting the EoR form. The letter will confirm whether your result has changed, but there will be no comments on your language performance.
5. If you are awarded a higher score than the original, a new TRF will be issued with the new score/s, and receiving organizations (if any) will be sent a copy of the new TRF. A full refund of the re-mark fee will be issued to you.
6. If there is no improvement to the original score, no new TRF will be issued and there will be no refund of the re-mark fee. Your original TRF will be returned to you with the pro forma letter.
